- 1. Complete four (4) copies of the "Request for Permission to Conduct Estate Sale" (page 2 of this policy) and three copies of "Estate Sale Inventory" (pages 3 and 4 of this policy):
 - **1.1** Give one copy of each form to Mutual President at time of approval.
 - **1.2** Give one copy of "Request for Permission to Conduct Estate Sale" to the Golden Rain News, if advertising the sale in the News.
 - **1.3** Give one copy of "Request for Permission to Conduct Estate Sale" to Security Dept.
 - **1.4** Post copy of "Estate Sale Inventory" at place of sale.
- **2.** Provide one (1) copy of a sales contract or agreement to Mutual Rep. at time of approval.
- 3. Selling agent must show proof of Seal Beach Business License for person conducting sale (business license not required if person conducting sale is an immediate family member). Person conducting sale must be present at sale site at all times
- **4.** Provide either of the following:
 - **4.1** Proof that a "Notice of Intention to Withdraw" form has been completed and submitted to the Stock Transfer Office.
 - **4.2** For a deceased resident, a copy of a death certificate for a deceased resident or for a living resident, a document that certifies that living resident is in an assisted living facility and does not plan on returning to the unit.
